Here are a couple of important things you need to know:

1. Trailers are for **OUTREACH EVENTS ONLY**.
2. Trailers are on a first come first serve basis. Therefore you **MUST** plan your events in advance.
3. You are required to pick-up and return the Outreach trailer.
4. ***You are required to provide an insurance rider at the time of pickup.***  
This rider releases the North Texas District Council from any liability.
5. You are responsible for any and all damages to the trailer, inflatables, and/or lost items.
6. **\$500 deposit** is refundable when trailer and contents are returned undamaged and without anything missing.
7. **Please make sure bounce houses are dry before storing.**
